CODE REQUIREMENTS (MUNICIPAL CODE 8.04.200)

The restrictions imposed herein shall apply to all dumpster, refuse containers and private rental storage containers placed on any public street, public sidewalk or alley at any time, as well as private property.

- 1) No dumpster/refuse container shall be allowed to be placed in any manner so as to block any public street, public sidewalk or alley, utilized for vehicles, bicycles and/or pedestrians.
- 2) No dumpster/refuse container shall be allowed to be placed on public streets.
- 3) **If there is absolutely no space for a container off the street, the Building Inspector must certify that the container may be placed on the street. Containers/Dumpsters may not be placed on street without obtaining Village approval first.** When absolutely necessary to place dumpster/container on street, there must be a barrier placed on both ends and flashing lights must be affixed to the unit. There must be placed under the unit, padding, plywood or a like material to prevent damage to or depressions in the roadway. A building permit prior to the delivery of the dumpster/container is required.
- 4) A contractor must be registered with the Village.
- 5) The maximum amount of time that the container can be there is five days.

IT SHALL BE THE RESPONSIBILITY OF THE PARTY ORDERING THE CONTAINER/DUMPSTER TO SEE THAT THE SUPPLIER IS LICENSED TO SUPPLY SUCH CONTAINERS WITHIN THE VILLAGE OF WESTCHESTER
