**AN ORDINANCE WAIVING COMPETITIVE BIDDING AND AUTHORIZING THE
PURCHASE OF A 2014 FORD TAURUS FOR USE BY THE VILLAGE OF
WESTCHESTER POLICE DEPARTMENT**

WHEREAS, the corporate authorities of the Village of Westchester (“Village”) find that it is advisable, necessary, and in the public interest that the Village purchase a 2014 Ford Taurus with Vehicle Identification Number 1FAHP2DB2EG112989 (“Vehicle”) for use by the Police Department; and

WHEREAS, the Village has obtained a quote from Car Max for purchase of the Vehicle, in the amount of \$15,318.00; and

WHEREAS, the corporate authorities of the Village may, by a vote of two-thirds of the trustees then holding office, waive the requirement of the Village of Westchester Purchasing Policies and Procedures Manual to publicly advertise and solicit competitive bids for a purchase in excess of fifteen thousand dollars (\$15,000.00); and

WHEREAS, the corporate authorities of the Village have determined that it is advisable, necessary and in the best interests of the Village to waive competitive bidding requirements and to authorize the purchase of the Vehicle from Car Max.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village Westchester, Cook County, Illinois, as follows:

Section 1: The corporate authorities of the Village hereby waive the competitive bidding requirements of the Westchester Purchasing Policies and Procedures Manual and hereby authorize the purchase of the Vehicle from Car Max, in the amount \$15,318.00.

Section 2: This Ordinance shall be in full force and effect from and after its passage

and approval as provided by law.
