## MEETING MINUTES FIRE AND POLICE COMMISSION MEETING October 4, 2017

### CALL TO ORDER:

The meeting was called to order at 6:04p.m. followed by the Pledge of Allegiance. Responding present to roll call were Commission Chair Thomas McCarthy, Commission Secretary Brian Kuratko and Commissioner James O'Shea. Also present was Attorney Jason Guisinger on behalf of Attorney Jurusik.

### APPROVAL OF MINUTES:

Commissioner Kuratko entertained a motion to approve the minutes for the September 6, 2017 meeting. The motion was seconded by Commissioner O'Shea. The motion passed and the regular meeting minutes for September 6, 2017 were approved.

### NEW BUSINESS:

Commissioner McCarthy discussed the fall Seminar which will be held by the Illinois Fire and Police Commissioners Association on November 3<sup>rd</sup>, 4<sup>th</sup> and 5<sup>th</sup>, 2017. This will be held in Naperville at the Hotel Arista.

### OLD BUSINESS:

Commissioner McCarthy discussed the Fire Captain promotional exam and explained that the Assessment will be given by the Illinois Fire Chiefs on October 24<sup>th</sup>. IO Solutions will then be conducting the written exam on October 26<sup>th</sup>.

Commissioner McCarthy then went on to discuss the Police Sergeants Promotional Exam. Officers were given 10 days to apply for Military Veteran's points. These points were received and applied to the candidates' scores. The Final Register for Police Sergeant was presented, and a motion was made by Commissioner O'Shea to approve. The motion was seconded by Commissioner Kuratko and passed unanimously. The Register will expire on October 4, 2020, three years from the date of signing.
